**LAKE RESOURCES – CLEANSING NOTICE AND APPENDIX 3B
NEW ISSUE OF SECURITIES**

- **Lake closes oversubscribed placement of A\$4.5 million, issues shares and will seek the listing of the attached options which make take some weeks.**
- **Patersons Securities Limited and Hunter Capital Advisors Pty Ltd acted as Joint Lead Managers**

For the purposes of section 708A(5)(e) of the Corporations Act 2001 (Cth) (the “Corporations Act”), Lake Resources N.L (the “Company”) hereby provides notice that on the 27 March 2018 the Company issued 33,333,335 new Ordinary Shares in LKE at \$0.135 per share to sophisticated and professional investors, to raise \$4,500,000 before costs; which included 762,964 which were issued in lieu of cash fees for brokerage to service providers.

Please see the attached Appendix 3B for details on the share issue.

Pursuant to the provisions of section 708A(5)(e) of the Corporations Act, the Company states that:

- (a) The securities were issued without disclosure under Part 6D.2 of the Corporations Act;
- (b) This notice is being given under section 708A(5)(e) of the Corporations Act;
- (c) As at the date of this notice, the Company has complied with:
 - (i) The provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - (ii) Section 674 of the Corporations Act; and
- (d) As at the date of this notice, there is no excluded information as defined in sections 708A(6)(e), 708A(7) and 708A(8) of the Corporations Act.

The Company also hereby provides notice that on the Company intends to seek the listing of new Listed Options in the Company which would include 16,666,667 new Listed Options with an exercise price of \$0.20 and a 15 December 2018 expiry to the same sophisticated and professional investors participating in the placement as noted above. The Company will soon provide a transaction specific short form prospectus under s713 to allow the provision of new securities to be lodged with ASIC and then seek listing of the options on the ASX.


