CLEANSING NOTICE

For the purposes of section 708A(5)(e) of the Corporations Act 2001 (Cth) (the "Corporations Act"), Lake Resources N.L (the "Company") hereby provides notice that on 28 September 2018 the Company issued:

- (1) 10,000,000 new Ordinary Shares in LKE at \$0.10 per share following the conversion of LKEO options in to Ordinary Shares In accordance with the Agreement entered into by Long State Investments (Investor), as disclosed 25 September 2018. An amount of restricted cash has been deposited by it with the Investor, related to the two tranches of approximately \$333,500, in accordance with the swap arrangement;
- (2) 124,131 new Ordinary Shares in LKE at \$0.10 per share following the conversion of LKEO options in to Ordinary Shares; and
- (3) 19,000,000 new Ordinary Shares in LKE at nil cash consideration to Petra Energy SA as approved by shareholders at the Company's EGM held on 15 June 2018.
